Professional Change Summary

We are pleased to announce the release of PC-ACE Pro32 version 2.22. This upgrade contains several CMS Medicare Mandates and product enhancements effective 7/1/2010, including these highlighted changes:

CMS MEDICARE MANDATES

CR6589 – HIPAA Version 5010 for Transaction 835 - Health Care Claim Payment / Advice and Updated Standard Paper Remit

- ◆ SDI will implement changes to support 5010 requirements over a period of several quarters beginning in the Q2 2009.

ADDITIONAL CMS MANDATED CHANGES

CR6809 - Quarterly HCPCS Code Changes - July 2010 Update

- ◆ Added new HCPCS code effective 7/1/2010
 - **Q2025** – ORAL FLUDARABINE PHOSPHATE
- ◆ Added new codes effective 1/1/2010
 - **Q2026** – RADIESSE INJECTION
 - **Q2027** – SCULPTRA INJECTION

Note: This change request lists the effective date for HCPCS codes Q2026 and Q2027 as 3/23/2010, however, we have opted for the 1/1/2010 effective date published in the July 2010 IOCE Specifications (CR6967, Transmittal 1969).

- ◆ Modified the Professional Roster Billing Module to add support for the AMA defined H1N1 vaccine/admin CPT codes
 - ◆ Added the vaccine CPT code entries "90664 - PNEUMOCOCCAL VACC, 13 VAL IM (CPT)", "90666 - FLU VACC PANDEMIC LIVE NASAL (CPT)", "90667 - FLU VACC PANDEMIC NO PRSV IM (CPT)" and "90668 - FLU VACC PANDEMIC ADJ IM (CPT)" to the influenza vaccine code dropdown selection list

- ◆ Modified the claim generation code to use the administration code "90470 - IMMUNE ADMIN H1N1 IM/NASAL" when generating claims for these CPT vaccine codes

- ◆ Added several new vaccine code validation edits to support the new vaccine codes (effective 7/1/2010)

- ◆ Modified an existing vaccine code validation edit such that it expires effective 7/1/2010

- ◆ Modified an existing Professional claim edit which enforces the non-zero service line charges requirements such that it is bypassed for the new H1N1 influenza vaccine HCPCS codes "90664", "90666", "90667" and "90668"

MODIFICATIONS IN SUPPORT OF ANSI (HIPAA) COMPLIANCE**Professional Claim Form Modified to Support Accident Country**

♣ Modified the Professional claim form to add the "Accident Country" field to the Ext. Patient/General tab. This field populates the Accident Country (CLM11-5/2300) element in the professional ANSI-837 transmission file. Modify the Professional Claim Import Module and the Professional Claim Prepare Module to support this new field.

GENERAL PRODUCT ENHANCEMENTS**Adobe Acrobat Enhancement to Professional Claim Print Module**

♣ Modified the Professional Claim Print Module to enhance the Adobe Reader claim printing mechanism to automatically create the special "TrustManager" registry entry when printing claims (preview or print) with Adobe Reader 9.3 or later. The code will

adapt automatically to any future Adobe Reader version. This enhancement is in response to a change in the security behavior of Adobe Reader 9.

INSTALLING THE UPGRADE

Perform a full PC-ACE Pro32 database backup before installing the upgrade. To install the upgrade, run the attached PCACEUP.EXE file using Windows Explorer or equivalent and follow the simple upgrade wizard steps. When prompted, enter the upgrade password provided by your software supplier. For networked instructions, it is recommended (but not required) that the update be run from the server's console.

IMPORTANT: The recommended database backup is for safety purposes only, and should NOT be restored after successfully installing the update. The update program preserves all existing claims and reference file settings.
